Current Issues at the Practice:

Same day appointments are now available online from 8am.

Due to an immense amount of work by Ashley, the CCG report has now been upgraded to "Good" in every department.

Drs Shah and Khan have joined the Practice. Morgan has left the Reception Team and Jak Linsell, the IT manager has also left due to travel difficulties. Two new receptionists have been appointed.

The nursing team has now stabilised and all members are settling in.

CARERS SUPPORT MEETING:

Although the number of carers who attended the meeting is small, it is still felt to be worthwhile as those who do attend gained considerable help.

Despite all the adverse publicity about the NHS and how doctors are leaving the Service and GPs are not being recruited, here at Simpson House, we have continued to receive the same good service we have always had.

The new telephone system has been implemented and, I believe, from a patient's point of view it has improved the appointments system. I, for one, have found it considerably less stressful to ring at 8 30 am and be told I am fourteenth in the queue with regular updates of my position, rather than having to continuously redial until I get the ringing tone.

The Newsletters have continued to be published four times a year and we thank Ashley for continuing to do this even though she has been on Maternity Leave. The newsletters are informative and interesting to read and we need to look at ways of getting them out to more patients.

The CQC inspection took place in July last year and the final report was favourable. Thank you to those committee members who were willing to be interviewed by the Inspectors. Whatever the result of their inspection, we, the patients know that our doctors, medical and admin. staff are doing an excellent job and have our interests at heart.

The Carers' Support Group Coffee Mornings, which take place on the third Friday of each month in the Methodist Church across the road continue to be a valuable and valid resource for carers who are in need of support. It is regularly attended by 3 or 4 Carers (not necessarily the same ones) and a similar number of Committee members. I want to thank, especially Roger, Doris, Asoke and Cherry from the Committee who come along most weeks.

It has been good to have the notice board outside on which we can advertise PPG events and activities.

I attend the Harrow Patient Participation Network (HPPN) meetings regularly and get information on the wider front of the NHS and what is happening with the Clinical Commissioning Group (CCG). If anyone would like to attend with me, you would be most welcome.

Finally, I want to thank all the committee members for their support throughout this year, especially Pat, Marilyn and Cherry who have edited the Newsletter. Pat has not been well over recent months and has been unable to take minutes at PPG meetings and I am very grateful to Geoff who has willingly taken on this task. And on behalf of all the patients of Simpson House a big thank you to our doctors and all staff members, who give us an excellent service.
